The College reserves the right to change Academic Regulations, the Course Catalog, health and safety regulations, building access policies, or other College operations or program elements at any time, with or without notice, in its sole discretion and for any reason, including in order to effectively administer the academic program or respond to emergencies or economic needs. ** All CSL & MSL registered units, whether above or below 24 units total, are billed on a per-credit basis.

*** The activity fee is charged to all students annually. Students who attend in the Spring semester but not the Fall semester are charged the activity fee in the Spring semester.

**** MBE Support Fee is charged annually. Students who attend in the Spring semester but not the Fall semester are charged the MBE Support Fee in the Spring semester.
