The College reserves the right to change Academic Regulations, the Course Catalog, health and safety regulations, building access policies, or other College operations or program elements at any time, with or without notice, in its sole discretion and for any reason, including in order to effectively administer the academic program or respond to emergencies or economic needs. Such changes include but are not limited to: (1) requiring masking or vaccines; (2) changes to computer equipment requirements; (3) canceling or adding classes or changing the format of instruction (e.g., in-person or online), examination formats, or grading (e.g., from normal grading scales to CR/NC); (4) changing, modifying, or clarifying Academic Regulations; and (5) elaborating new attendance policies. Tuition and mandatory fees have been set regardless of the method of instruction and the College's policies and programs and will not be refunded in the event instruction occurs remotely for any part or the entirety of the Academic Year or in the event of other changes in the College's policies or programs.

* Tuition and fees are estimated and subject to change by the State Legislature, the Governor's office, or the College's Board of Directors. They are subject to change without notice.

** All CLS & MLS registered units, whether above or below 24 units total, are billed on a per-credit basis.

MLS and CLS students will be charged the MBE Support Fee if they are enrolled in a course that requires AdaptiBar. Students who are enrolled in a course that utilizes AdaptiBar in the Spring semester and not in the Fall semester will be charged the MBE Support Fee in the Spring semester.

The University of California requires all enrolled students to have health insurance coverage. Students are automatically enrolled in and billed for the UC Student Health Insurance Plan (UCSHIP). Students who can demonstrate that their health insurance meets the University of California's minimum criteria may request a waiver from UCSHIP. Students who have successfully waived out of UCSHIP will not be charged the Health Services Fee and will not have access to Carbon Health as a student. Students who are enrolled in UCSHIP must pay the Health Services Fee and will have access to Carbon Health.

***In addition to the enrollment fee, part-time students may be required to pay additional fees, such as the Activity Fee, Health Services Fee, MBE Support fee, and UC SHIP Insurance Premium. Contact the Office of Fiscal Services for additional information.

Tuition and Fees Information

In addition to the enrollment fee, UC Law Students also pay for other fees, as indicated below:

Activity Fee: The Student Activity Fee is a fee that every UC Law SF student pays. It allows for providing student activities, services, programs, and initiatives. The activity fee is charged at the beginning of the academic year (Fall semester). Students who attend in the Spring semester but not the Fall semester are charged the activity fee in the Spring semester. The fee that students pay is distributed to different programs/initiatives as follows:

- \$100.00 – Student Services- Wellness activities
- \$40.00 – UC Law Associated Students (UCLAS)
- \$4.00 – Student Services Special Events
- \$8.00 Childcare
- \$5.00 Bay Area Legal Aid

MBE Support Fee: Charged at the beginning of the academic year (Fall semester). Students who attend in the Spring semester but not the Fall semester are charged the MBE Support Fee in the Spring semester. Students gain access to AdaptiBar, the largest database of actual prior-year questions released by the National Conference of Bar Examiners (the organization that creates the Multistate Bar Exam (MBE)).

Health Services Fee: All students, whether having UC SHIP or other insurance, get access to all the services available at Carbon Health for UC Law SF students. The Student Health Fee that you pay each semester covers these services, so there are no additional costs or copays. Please visit the [Carbon Health page](#) for additional information.

UC SHIP Insurance Premium: All enrolled students are eligible for the University of California Student Health Insurance Plan (UC SHIP). The annual cost is divided into two payments, one for the Fall semester and one for the Spring/Summer semesters. A student with proof of comparable health insurance may request a waiver from UC SHIP if they can demonstrate proof of comparable health insurance that meets the University of California minimum criteria.
